

To provide the support and resources necessary for our clients to begin living sober lives and reconnect with their families, community, and culture.

What is a Healing to Wellness Court?

- Tribal take on a state drug court model
 - National Drug Court Institute. NDCI's tribal healing to wellness court planning initiative
 - Not just culturally competent cultural & community focus
- Research-based with accepted set of best practices
 - Most statistically-effective method of working with drug and alcohol offenders
 - Uses incentives and short/quick sanctions to encourage compliance

 - Uses case management, wrap-around services, and effective supervision to change behavior and lives

NATIONAL DRUG COURT INSTITUTE MENTOR COURT SINCE 2019

- The National Drug Court Institute (NDCI) was formed in 1997 in response to a great need for standardized, evidence-based training and technical assistance as a result of the rapid expansion of problem-solving courts across the US.

THE IMPORTANCE OF INCORPORATING CULTURE

- Restore identity sense of loss, non-belonging
- Involves community tribal member designed and delivered
- Promotes a healthy lifestyle and builds a positive self-image
- Compliments treatment services
- Incorporates history and language education
- Assists in preventing relapse

CULTURE

Program Requirements

- Cultural event monthly
- Integrations with cultural practices (e.g. smokehouse)
- Support groups (e.g. red road)
- Sweat lodge

Sanctions and program responses

- Chopping wood
- Assisting elders
- Community give back
- Assisting with ceremonies and funerals

COLLABORATION WITH OTHER COURTS

Past collaborations

- Brought state court proceeding into Wellness Court through bench probation/supervision agreement
- Collaborate on joint resolutions (involving dismissal or minimal jail time resolutions of state matters) to allow defendants to participate in wellness court

Joint jurisdiction court?

- Would allow us to address the substance abuse challenges of entire families/social groups
- Establish legal process to allow state courts to transfer jurisdiction or supervision to Tulalip for tribal members and/or reservation residents.
