

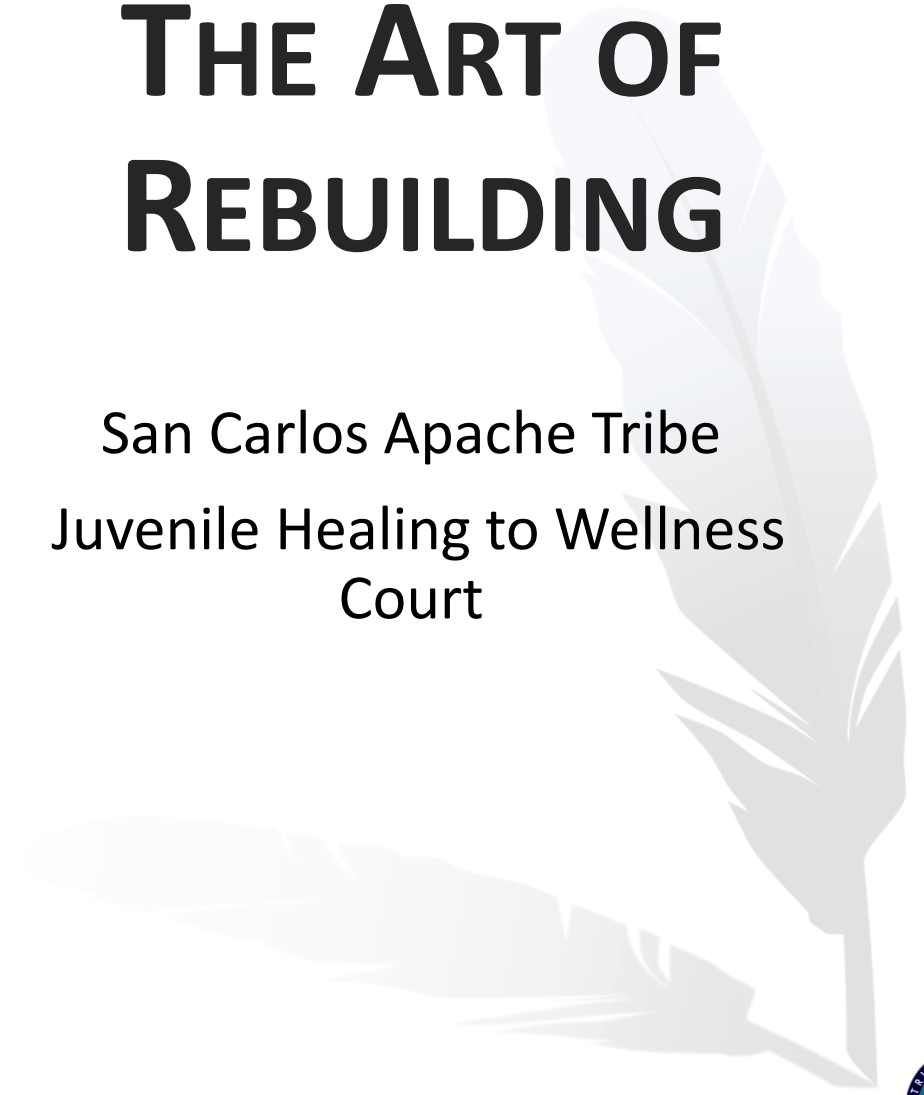

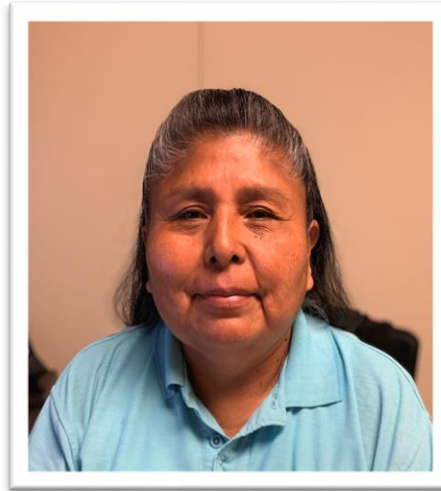

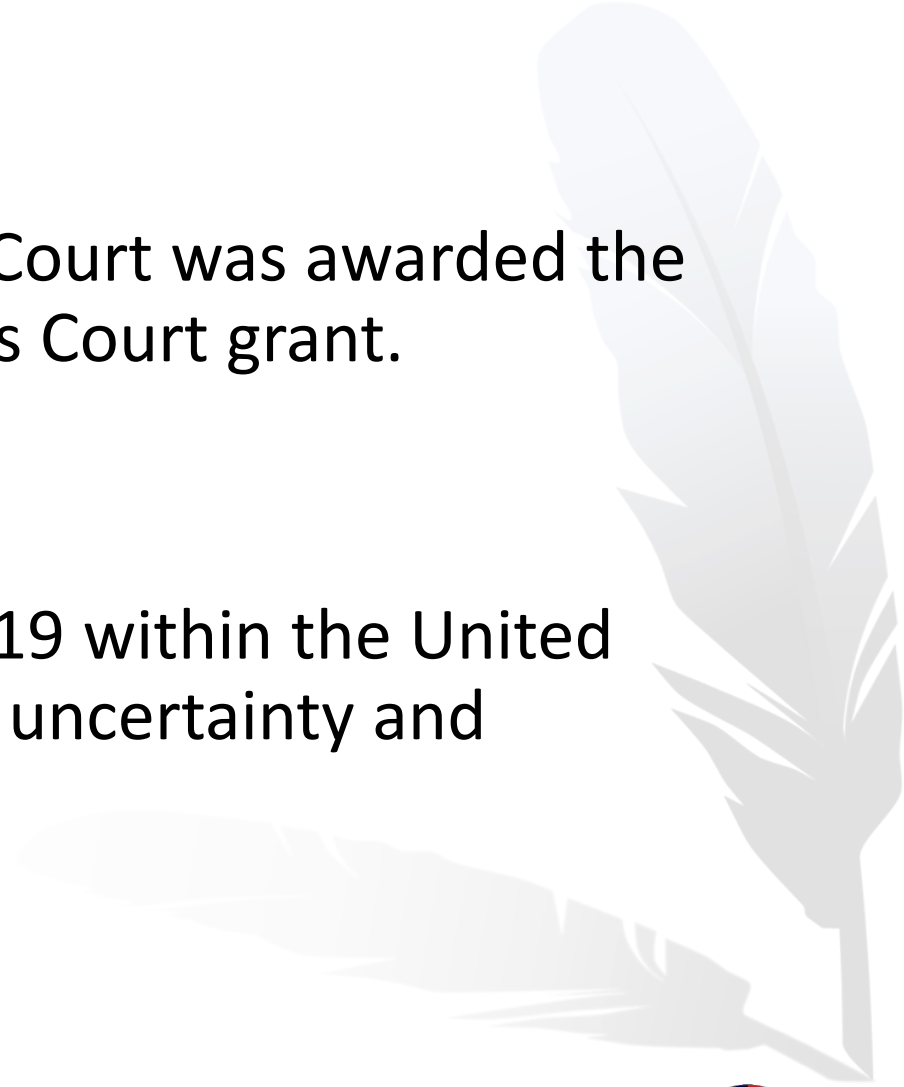

JUVENILE HEALING TO WELLNESS GRANT

- October 2020, the San Carlos Apache Tribal Court was awarded the OJJDP CTAS PA 8 Juvenile Healing to Wellness Court grant.
 - 5-year award for Planning and Implementation
- Unforgiving arrival of the novel virus COVID-19 within the United States caused a major setback adorned with uncertainty and challenges.

- Tribal mitigation measures
- Struggles with infrastructure
- Court Administrative Orders

REBUILDING

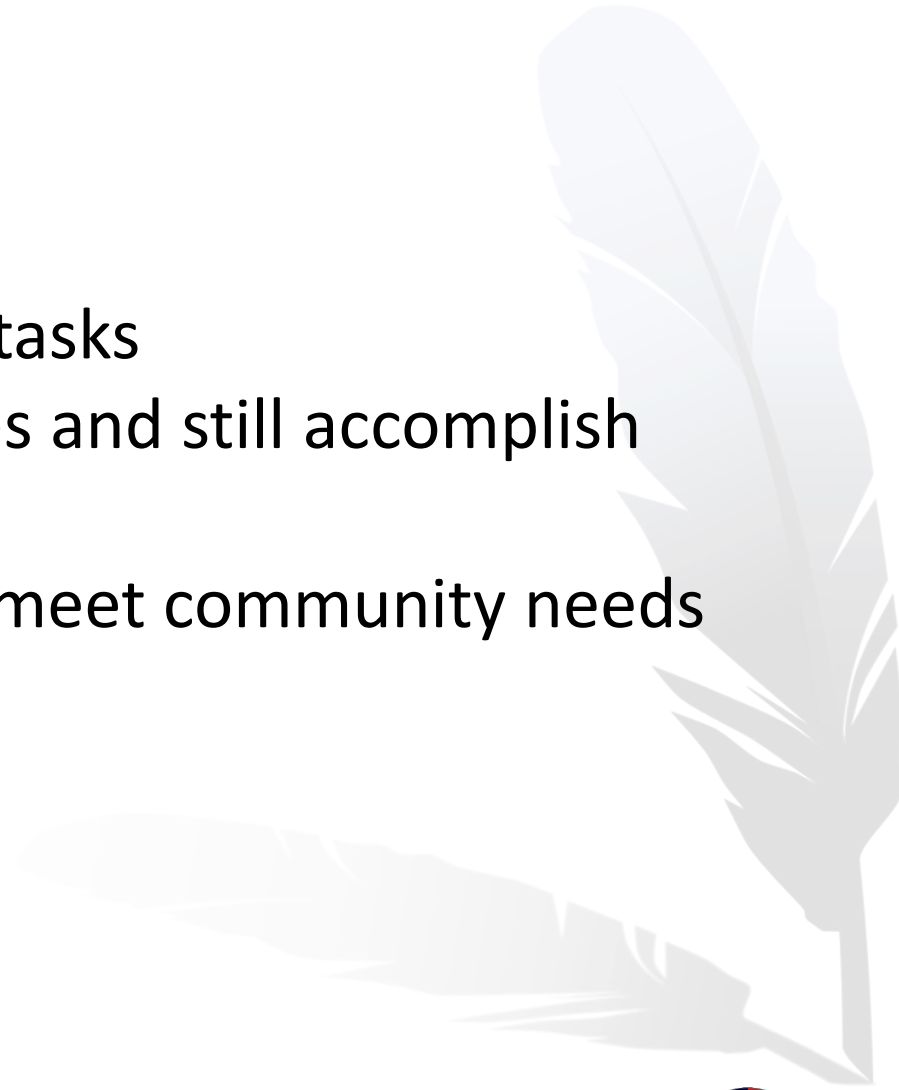
- Finding Common Ground

REBUILDING

- Strong Communication with Grant Staff
 - Identify challenges in the timelines or tasks

- Adapt short-term and long-term goals to meet community needs
