► LAW ENFORCEMENT'S ROLE WITHIN THE TREATMENT TEAM

- Connection between the Wellness Court and the Police Department
 - Assist with Welfare checks on participants during and after business hours
 - Accompany other officers, probation, treatment providers
 - Has your team developed guidelines on “check-ins”
 - Assist with random drug/alcohol screenings
 - Provide information to the Treatment Team on incidents involving the participant
 - Eyes and Ears of the Community
 - Meet with families, neighbors, friends, etc. on behavior that is concerning about the participant
 - Assist other Treatment Team members with recommendations such as recommending offenders for the Wellness Court.



► IMPORTANCE OF LAW ENFORCEMENT ON HEALING TO WELLNESS COURT TEAM

- When a representative from Law Enforcement attended hearings regularly, Drug Courts were over 80% more effective at reducing crime and 60% more cost effective. Carey et al. 2008-2012
- Law Enforcement is a member of the treatment court team: Recidivism reduction * ^ 88%
- Law Enforcement attends court sessions: Recidivism reduction * ^ 83% *Recidivism reduction relative to courts that do not follow these practices. NPC Research Key Components Study 2008
- Assists in the interview process: The officer assigned to the Treatment Team is able to research the applicant prior to the interview. The officer will have access to information about the applicants prior criminal history as well as any reports that were made about or filed by the applicant. The officer will also be able to speak with the arresting officer about the incident that the applicant is in custody for.
