- Directs how Healing to Wellness Court interacts within the judiciary
- Protects people's rights



Why We Need Laws

- It binds the government to engaging in an act
- Creates commitment inside and outside your Nation
- Enactment process educates Council and community

- What kinds of laws can do this?
 - Philosophical statement
 - Laws creating a HWC
 - Referral sections in your criminal code/family code/juvenile code
 - A HWC code



Laws Increase Sustainability

- How are cases referred?
- How does the Court interact with other agencies in other branches of government?
Can the Court interact with these agencies?
- Who supervises the HWC and the HWC Coordinator or HWC Court Clerk? Who manages the grant/funding?
- What kinds of laws can do this?

- Right to confidentiality
- Right to a trial
- Freedom from unreasonable search and seizure
- How work together as a team to promote participants' right to a healthy life

Laws that Directly Impact HWC

- General law granting court authority to create a HWC
 - Section referring to restorative justice
 - Specific section creating the HWC
 - Specific law creating HWC – ‘there shall be a HWC’
 - General Tribal Council Resolution
 - Specific Healing to Wellness Code
 - Should it be detailed?
 - Laws impacting entry
 - Minimum offense
 - Violent offense that screen people out
 - Deferred sentencing

- **Muscogee (Creek) Nation of Oklahoma
Chapter 6. Family Drug Court Program**
- **§6 – 101. Establishment of a program**
There is hereby established a Family Drug Court Program within the Muscogee (Creek) Nation’s judicial system.
- **§6 – 102. Powers and authority of Court**
The judge of the Muscogee (Creek) Nation District Court is hereby authorized to order and/or impose sanctions and incentives for participants who enter into the Family Drug Court Program. The Court’s powers and authority hereunder shall include, but are not limited to the following...
- **§6 – 103. Rules and procedures**
The District Court may, in its discretion, adopt written rules and procedures for the conduct of hearings and proceedings within the Family Drug Court program and the administration of cases therein, provided that copies shall be public documents...

- **Muscogee (Creek) Nation of Oklahoma**
Chapter 6. Family Drug Court Program
- **§6 – 104. Family Drug Court Implementation Team**
A. There is hereby established the Family Drug Court Implementation Team, which shall consist of at least (1) representative from the following agencies or departments of Muscogee (Creek) Nation) ...
- **§6 – 108. Cooperative agreements or contracts**
A. The Principal Chief... is hereby authorized to negotiate and enter into on behalf of the Muscogee (Creek) Nation appropriate cooperative agreements with state and local governments for integrating and/or coordinating the Muscogee (Creek) Nation Family Drug Court Program with agencies of such other governments. ...

- **Sec/ 7C-6. - Cherokee Tribal Drug Court procedures**
 - (a) Establishment of policies and procedures.
 - ...
 - (3) In order for the policies and procedures to be amended or modified, there shall be present at the Cherokee Tribal Drug Court Team meeting the judge and at least four other members of the Cherokee Tribal Drug Court Team.
 - (b) Sessions
 - (1) All Cherokee Tribal Drug Court sessions shall be closed to the public except for invited guests as allowed by HIPAA regulations. ...
- **Sex Offender Prohibition**

People categorized as “Sexual Offenders” are not eligible to participate in Cherokee Tribal Drug Court. ...

- **Rule 87. Entry of guilty plea; deferred acceptance of plea ...**



- Expungement
 - Can the HWC expunge a criminal conviction upon successful completion?
 - Family/Juvenile laws
 - Can transfer a family/juvenile case
 - Does the HWC have the ability to modify visitation?
 - Judicial ethics
 - Ex parte communications
 - New judge for sentencing terminated participants

- Probation laws
 - Is there a maximum number of positive drug tests before probation revocation allowed?
 - Dry Reservations
 - Are arrests/jail mandated for all positive tests – even those done by treatment providers?
 - Non-drug crimes
 - Laws that dictate what must happen when a participant picks up a non-drug offense?
- 

- Process for entry into HWC and waiver of rights
 - Criminal case
 - Family/dependency case
- Legal consequences of graduation/termination
- Communication across agencies/branches of government
- Where do I document waiver of defendant's rights?

 - Criminal/juvenile/family code
 - Healing to Wellness Code
 - Adopted by Tribal Council
 - Policies and Procedures
 - The nuts and bolts of Healing to Wellness
 - How Team functions
 - How participant moves through HWC
 - Adopted by Court or Tribal Council

Steps when we get home

- Review Constitution
 - What applies?
 - Is there anything that might prohibit HWC?
 - Review your tribal laws
 - What applies?
 - What supports your HWC or detracts from it?
 - What is missing?
 - Is there anything that might prohibit HWC from functioning in the best possible way?
 - Does it make your HWC more sustainable?
 - Review policies and procedures
 - If your team doesn't go home from the training, will the new team know what to do from your policies and procedures?
